The above animals can be sold only if captive bred/domestic Game Breeders License from Indiana Department of Natural Resources (DNR) Must meet 312 IAC 9-10-4 and IC 14-22-20 Producer selling meat/poultry products from farm Must be slaughtered and processed at a state or federally inspected facility that is equal to IC 15 -17 5; 345 IAC 9 and 10
