Sex Offenses, Nonforcible —(Except Prostitution Offenses) Unlawful, nonforcible sexual intercourse Incest—Nonforcible sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law Statutory Rape—Nonforcible sexual intercourse with a person who is under the statutory age of consent
